### Equipment:

Traditional uniforms for forms, sparring, & weapons  
(must cover elbows) Foam Safety equipment (head,  
hands, feet) is required for all Sparring divisions. All  
Sparring and TDS divisions require **mouthpieces** for  
all competitors, and **Groin protection** for all male  
competitors. TDS competitors must wear approved  
caged headgear, rash guard, open hand gloves, shin  
guards, and sport bra for all female competitors.

### Rules: USAMA Tournament Rules:

Point Sparring:

5 Point Match All Divisions, 2 Minute Fight Time

Light (touch) Face Contact Adult Brown & Black Belts

**NO** Face Contact for Youth, Novice Adults, or Colored  
Belt Adults.

2 minutes fighting time. Light (touch) face contact Adult Brown & Black Belts.
