Traditional uniforms for forms, sparring, & weapons (must cover elbows) Foam Safety equipment (head, hands, feet) is required for all Sparring divisions. All Sparring and TDS divisions require mouthpieces for all competitors, and **Groin protection** for all male competitors. TDS competitors must wear approved caged headgear, rash guard, open hand gloves, shin guards, and sport bra for all female competitors.
