Equipment:

Traditional uniforms for forms, sparring, & weapons (must cover elbows) Foam Safety equipment (head, hands, feet) is required for all Sparring divisions. All Sparring and TDS divisions require mouthpieces for all competitors, and **Groin protection** for all male competitors. TDS competitors must wear approved caged headgear, rash guard, open hand gloves, shin quards, and sport bra for all female competitors.

5 Point Match All Divisions, 2 Minute Fight Time Light (touch) Face Contact Adult Brown & Black Belts <u>NO</u> Face Contact for Youth, Novice Adults, or Colored Relt Adults.
