Beautiful Custom Medallions awarded for 1st, 2nd, and 3rd places; Custom Medals for 4th place. Medals for all Youth Forms competitors.

Grand Champion Trophies will be awarded for Black Belt Forms, Adult Kyu Forms, Youth Beginning Forms, Youth Intermediate Forms, Youth Advanced Forms, Black Belt Weapons, Adult Kyu Weapons, Youth Weapons, Black Belt Men Sparring, & Black Belt Women Sparring. *(10 USAMA World Champion Titles)*

Finals Competitors will consist of:

All 1st Place Forms Winners; All 1st Place Weapons Winners; 1st Place Adult Black Belt Men Sparring & 1st Place Adult Black Belt Women Sparring. (Adult Black Belt Forms Winners will be narrowed down to 2 on Saturday and the Final 2 will perform the Bunkai in addition to their Form at Finals) (Adult Black Belt Weapons Winners will perform 2 different weapons forms, each featuring a different weapon at Finals) Winners will be competing for 10 Beautiful Grand Champion Awards!

Competitor Equipment/Attire:

Mandatory Forms & Weapons Attire: Traditional uniform respective to his/her style. No T-shirts.

Mandatory Sparring Equipment & Attire: Approved Foam Handgear, Headgear, & Footgear, Mouthpiece (Double mouthpiece for those with braces), & Groin Protection (All males). (Check with Chief Referee for Gear Approval) USNKF equipment ok. Must wear martial arts uniform; No T-Shirts or Sleeveless Tops.

Mandatory Koshiki Gear: Mouthpiece & Groin protection (All males). Headgear, Chest Protector, & Hand Covers will be provided at ring. Hand Covers will also be available for purchase.

<u>Prohibited items in Sparring & Koshiki:</u> For the safety of our competitors, <u>No</u> metal or hard plastic joint braces, **nor** will plaster or fiberglass casts be allowed. No regular eyeglasses allowed, however, safety sport goggles are allowed. Medical devices must be approved by Medical Personnel and Chief Referee.

<u>Disqualification</u>: A competitor may be disqualified for excessive contact, illegal techniques, or unsportsmanlike conduct and <u>not</u> entitled to a refund nor allowed to fight in any further events that day. Coaches and Spectators' unsportsmanlike conduct may also be cause for a competitor's disqualification.

Judges Attire for Tournament: <u>Blue</u> Blazer or Sport Coat, <u>Gray</u> dress pants or skirt with white dress shirt or Traditional martial arts uniform. We appreciate your professionalism.

Judges Meetings:

We will be conducting Judges' Meetings on Saturday & Sunday mornings at 9:00am in the meeting room at the Adventure Commons just before we begin the tournament. All aspects of the rules will be covered for each day's Events.


